NEWS REGARDING CEDEM RESEARCH AND PROJECTS

Since March 2020, Jérémy Mandin joined the **ERC-funded project MiTSopro**. He started to conduct qualitative fieldwork on French citizens in situation of disability in Belgian mental health institutions.
